_____ Owner agrees to pay all fees in full. We accept cash, check, debit, or credit cards. There is a \$50 returned check fee.

_____ Boarders must be current on all vaccinations. You will be required to provide a copy of your pet's vaccination records from your vet at the time of boarding or before.

_____ If your pet is exhibiting any symptoms that suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, or diarrhea, please let us know before you bring your pet for boarding.

_____ Pets with flea and tick infestation will be treated with a bath and frontline at the owner's expense.

_____ Pets left ten days beyond the scheduled pick-up date without contact from the owner will be considered abandoned. Bark with Lark will then have the right to place the pet with a new owner. The original owner shall remain liable for all boarding and rehoming fees.

_____ The house brand is Nutri Source. If you are feeding another brand, please make sure you bring enough with you. Changing your pet's food may cause a severely upset stomach. If you forget food, we will charge \$2.50 per meal we provide.

_____ Owners are welcome to bring their own toys and bedding, however we cannot guarantee that they will be returned in the same condition. For safety reasons rawhides are not allowed.

_____ Owner agrees to pay all attorney/collection fees incurred by Bark with Lark in the collection of any boarding, grooming, training, or any damage done said pet to kennel property.

_____ All dogs must be on a 6-foot leash when entering or leaving the center. (No retractable leashes.)

_____ We cannot board any female dog in heat. Since we may have both neutered and unneutered males, we cannot guarantee the safety of all boarders if we have a dog in heat. If your intact female dog comes into heat while boarding, you will be charged an extra \$15 per day.

_____ I understand my dogs maybe photographed and/or videotaped and Bark with Lark can use these images.

_____ I understand that this agreement covers the current relationship between Bark with Lark boarding and me. Each time I bring my dog to Bark with Lark boarding, I affirm the terms of this agreement and the truthfulness and accuracy of all statements I make in this agreement. I have read and understand this entire agreement, I have had an opportunity to discuss it to my satisfaction with a representative of Bark with Lark boarding, and I agree to its terms.
